# Contributions, Fees & Charges Booklet

Includes information regarding Allowances & Assistance

#### RESIDENTIAL BOARDING FEES

Boarding fees are levied by the Department of Education on an annual basis.

To assist ease of payment these are divided into three instalments, payable at the beginning of each of the first three terms. In 2025 these fees will be \$9,563.00. Boarding fees are GST free.

- The first and second instalments of residential fees must be cleared by the end of Semester One for students to continue in residence in Semester Two.
- The third instalment is to be cleared before the commencement of Term Three.

No student will be permitted to commence Year 12 as a residential student unless prior repayment arrangements have been made with the Manager Corporate Services to clear outstanding fees from the previous year

NB: Students may attend the education programme in Year 12 as a day student.

## SUBJECT CHARGES & PERSONAL ITEMS

Parents will be issued with an itemised invoice for their student's fees in February 2025. The contributions, fees and charges outlined in this booklet have been reviewed by the College Finance Committee and been approved by the College Board.

These fees are to be paid as soon as possible after the start of the school year (as per itemised invoice) unless arrangement has been made with the Manager Corporate Services.

 Course Charges, Extra Cost Options & Other Optional Costs are to be paid if your child participates. An invoice for these items will be forwarded when your child participates.

#### **TEXTBOOK PURCHASES**

Personal Items Lists will be forwarded to you as soon as they are available.

Items on the list can be purchased online through Campion Education (information will be on the list provided) or any supplier of your choice.

If you know any recent ex-student, some textbooks may be available from them secondhand. The College does nothave any secondhand books for sale. Year 11 students ordering through Campion will receive their books at induction and Year 12 students willreceive their books in the first week of Term One.

#### TRADES PERSONAL PROJECTS

Engineering and Furnishing students will be able to commence a Trade personal project in Year 11.

They will design and complete a cost estimation which will be sent home for approval by parents/guardians prior to commencement of the project

A deposit of 50% will need to be paid prior to commencement of the project, with final payment being made before the project can be collected. Students are required to meet the full cost of their personal project. The cost of this project can be anywhere between \$10.00 - \$10,000.00 depending on the complexity and scale of the project.

#### **DFES / FIRE ALARMS**

There is a financial cost for any student involved or found to have instigated a FALSE ALARM.

This charge will be forwarded to Parents/Guardians. Currently the charge is \$1,337.00 but may be subject to change.

## STUDENT DAMAGE TO COLLEGE PROPERTY

If a student recklessly or maliciously damages College property, they will be required to pay for the cost of the repair or replacement.

#### **PAYMENT PLAN**

A personalised payment plan is an available option to assist parents/guardians to pay for fees and charges in affordable instalments.

#### **REFUNDS**

- If a student leaves the College through their own choice or through termination of residency, fees remain payable for the number of weeks the student has been in residence. Parents will be refunded the excess, if applicable, on a pro rata basis. No refund of fees or charges will be made for any short-term periods of absence.
- If a student ceases the educational programme at the College, pro rata of charges less the percentage of Government Subsidy will be refunded to parents according to the time of the year in line with the Department of Education Fees Policies.

#### **PAYMENT IN PERSON AT BANK**

It is imperative that you use the student number as the reference when depositing in the College account over the counter at a bank. With this method of payment, the only details that appear on the College statement is the name of the branch which the transaction has taken place at and the student number. If it is necessary for the College to request a voucher trace for the details of the payee, a \$13.50 fee is incurred which is the parents' responsibility to pay. ## **Financial Assistance**

#### COMMONWEALTH AND STATE ASSISTANCE

Boarding fees can be substantially reduced for families eligible for assistance through several State and Commonwealth Government schemes. An outline of these schemes follows, based on information available at the time of publication.

#### BOARDING AWAY FROM HOME ALLOWANCE (BAHA) - for isolated children

All recipients of the AIC boarding allowance, or second home allowance are eligible for the State Government Boarding Away from Home Allowance (BAHA).

This allowance is administered by the Department of Education and paid directly to the College and is to be deducted from the residential boarding fees only.

Application forms will be sent to you from the College in 2025.

# BOARDING AWAY FROM HOME ALLOWANCE (BAHA) AGRICULTURAL COLLEGES SPECIAL SUBSIDY

This allowance is to assist parents with secondary students attending and boarding at a Western Australian College of Agriculture, with boarding costs. Claimants apply for the subsidy through the Western Australian College of Agriculture where the student is boarding. The college provides application forms to applicants and payment will be made directly to the Agricultural College and is to be deducted from the residential boarding fees only.

This subsidy is not available if the parent/guardian or student is receiving –

- Youth Allowance at the away from home rate; or
- AIC Allowance from Centrelink; or
- ABSTUDY (if full boarding paid by Centrelink).

#### SECONDARY ASSISTANCE SCHEME (SAS)

The Western Australian Department of Education provides an allowance to assist eligible families with secondary schooling costs. To be eligible for the allowance the parent/guardian must hold a Services Australia (Centrelink) or Veterans' Affairs card that represents a statement of income for the family.

The allowance consists of two components:

For 2025 only these are -

- \$300 Clothing Allowance paid directly to the parent/guardian or the college.
- \$235 Education Program Allowance paid directly to the college.

Application forms will be available from the College at the beginning of the new year. A current Centrelink Pensioner Concession / Centrelink Health Care / Department of Veteran Affairs Pensioner Concession Cards **MUST** be presented or emailed with the form.

#### YOUTH ALLOWANCE

## **Financial Assistance**

#### **ASSISTANCE FOR ISOLATED CHILDREN SCHEME (AIC)**

AIC is a scheme provided by the Commonwealth Government which includes a basic boarding allowance and an additional boarding allowance to assist families with the costs of children boarding away from home to go to school.

The basic boarding allowance is indexed annually and is not means tested. It is available to children who:

- Are geographically isolated.
- Have a special education need.
- Have no reasonable access to a school.
- Meet a continuity condition.

The additional boarding allowance is subject to an income test and is indexed annually.

The AIC scheme is administered by Centrelink and paid directly to the family or the residential college. Please provide the College with a copy of your approval letter from Centrelink once it is available. Prices are subject to change at government discretion, please check with Centrelink. #### **ABSTUDY**

Indigenous students can apply for ABSTUDY which assists with boarding, travel, and tuition costs of those eligible. ABSTUDY is administered by Centrelink and paid directly to the family or the College.

#### STUDENT SUBSIDISED TRAVEL

The Student Travel Subsidy Scheme provides travel assistance to school and tertiary students who are geographically isolated. The two main types of travel support are:

- Subsidised fares for air, bus and train travel for eligible students who live within the defined remote area of Western Australia (see map)
- A road travel subsidy for eligible students who live anywhere within Western Australia but who must be driven in a private vehicle more than 56 km from home to the nearest:
- Appropriate government school with boarding facilities (if boarding facilities are necessary) offering classes in the grade or level in which the student is enrolled, or
- Regular passenger transport (bus stop, airport or train station please visit the <u>Transwa Plan Your Journey</u> website for regular passenger transport hubs and routes), or
- A school bus service operating between the student's home and the school they are attending.
